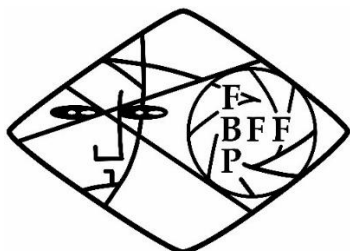

### **Rules**

The contest is open to all. FIAP rules will be applied.

Number of images : maximum 4 in each section and by entrant.

The same image may not be entered in the different sections.

The entrant declares that he or she is the only copyright holder of the submitted image.

Files must be in JPG format with the maximum dimensions of 1920 px horizontal and 1080 px vertical in 300 dpi, compression 7 – 12, maximum 3MB.

Winners will be asked (by email after judging) to provide higher resolution images for printing.

Registration, forwarding of files and payment of the entry fee (PayPal) will take place accordingly to the instructions on the screen published on our website

### **Note FIAP**

With the sole act of submitting his/her images or files to a salon under FIAP Patronage, the entrant accepts without exception and with no objection, - that the submitted images can be investigated by FIAP to establish if these obey to FIAP regulations and definitions even if the entrant is not a member of FIAP, - that FIAP will use any means at its disposal for this undertaking, - that any refusal to cooperate with FIAP or any refusal to submit the original files as captured by the camera, or failure to provide sufficient evidence, will be sanctioned by FIAP, that in case of sanctions following the non-compliance with FIAP regulations, the name of the entrant will be released in any form useful to inform the breaches of the rules. It is recommended to leave the EXIF data in the submitted files intact in order to ease eventual investigations
